**ORDER FOLLOWING SHOW CAUSE HEARING AND
FINDING HAL WOLFF IN CONTEMPT OF COURT**

This Court convened on this date regarding a Motion and Order to Show Cause why Hal Wolff should not be held in contempt of court for violating the Court's Order that was entered on January 4, 2023. In the January 4, 2023 Order, Hal Wolff was ordered to sign the release prepared by the Weiler Law Group, PLC within 24 hours. Hal Wolff failed to appear at today's hearing, despite being personally served the notice for today's hearing.

The Court finds that the release submitted to the Court on January 20, 2023 is not a proper release.


The Court also finds that Hal Wolff is in contempt of court for failing to appear at today's hearing.

THEREFORE, it is ordered that Hal Wolff shall be fined \$50 a day for each day that the proper release is not signed. This fine shall be paid by Hal Wolff personally.

IT IS FURTHER ORDERED, that if the release is not signed within seven days, Hal Wolff shall report to the Midland County Jail on February 8, 2023, where he will stay until he signs the proper release.

IT IS FURTHER ORDERED, that reasonable attorney fees and costs shall be paid to the attorneys for the trust, Weiler Law Group, PLC. The itemization shall be submitted to the Court. In the event Hal Wolff fails to pay any of these fines, costs or attorney fees, such amount shall be a lien on Hal Wolff's residual trust share.
