12-24-2005	Joel castigates his father, later calls Hal and tell him not to visit for Christmas and then breaks off contact with his father. (also restricting access to his father' 3 grandsons)
4-04-2007	Both Trusts are amended. New Trustee list: Chris, Hal (Barry George)
4-19-2012	Both Trusts are amended. New Trustee list: Chris, Hal, Cynthia (Barry George) (Per discussion Hal has with his father, Chris proposed he and Cynthia be top 2 Trustees)
8-21-2013	Richard Wolfe dies at 86 years of age
5-11-2015	Both Trusts are amended. Trustee list unchanged: Chris, Hal, Cynthia (Joe Weiler)

9-23-2015	Charlevoix lot line shift approved by Eveline Twp
10-13-2015	Hal and Ellen Wolfe drive to Charlevoix and attend Eveline Twp meeting. They want to make certain they understand the approval. 90 day deed submission requirement (instrument of conveyance) not mentioned to them.
11-05-2015	Both Trusts are amended. (Per Anne, Chris states: "Now Hal will get his just deserts.") Chris & Cynthia, Joel & Sue, Hal & Alan (Joe Weiler) Anne is guaranteed \$950K, Alan: \$475K, Hal – not mentioned! (Mom is confused and asks Hal why he isn't provided a Trust payout guarantee.)
Nov-2015	Hal sees copies of Trusts for the first time. He is discouraged at changes to Trustee lists. Hal was only told Joel would be added to Anne's Trust and that it was per Anne's desire. He was not told Cynthia and Sue would also be elevated / added as Trustees vs helpers. Hal was not told about strange new clause allowing a sister-in-law to remain Trustee.  (Most likely an "anti-Joel" clause – Trustee on paper only to support Chris) Hal was not told that Trustee changes would be made to both Trusts – only Anne's. Hal feels that he, Anne, his mother and the family have been taken advantage of.
4-15-2016	Hal submits copy of Proposed Amendment to Wolfe Trust to Joe Weiler via e-mail.  Proposed Amendment would name Hal as the Trustee of Charlevoix property.  Ellen had offered to "gift" Hal the Charlevoix property, but agreed to this instead.  Hal doesn't believe his share of the Trust will cover the value of the gift, so he declined, and suggested an Amendment as a more equitable alternative.  Joe W. sends copy of proposed Amendment to Chris Wolfe without consulting his client.
4-20-2016	Chris calls his mother (and sister) and tells his mother that he will "destroy her family" if she signs an agreement to allow Hal to legally manage the Charlevoix property. Under this direct threat from Chris, Ellen decides not to sign.  (I had heard this call occurred on Sat. April 16, but Anne notes it on the 20th.)  When Hal is told by Anne & Ellen the extend Chris went to to manipulate his mother, he pursues no further action on this matter to spare his mother further grief.
5-20-2106	3rd Amendment to Richard & Ellen Wolfe Trust (Chris & Cynthia now Co-Trustees with Ellen (Joe Weiler) (Trustee Power of Attorney given to Chris & Cynthis?)
7-13-2016	Ellen Wolfe signs a "Summerhouse gift agreement" to Hal.  Ellen & Hal visit Joe Weiler and ask him to review and notarize. Joe refuses.  The document is taken to Chemical Bank and notarized.
7-21-2016	Joe Weiler and a colleague visit Mrs. Wolfe at her home.  Joe request's Ellen rescind the Summerhouse gift agreement. Ellen refuses.
8-20-2016#	Chris asks Anne to take Mom's check book and send it to him. Anne complies.  (She had previously been told by Chris to remove donation letters from her mother's mail. She temporarily complied. Anne regrets both of these actions to this day, and Ellen was upset (& likely depressed) by this until the day she died.)

To this day Chris still claims that Hal sued him regarding this issue. He did not. Chris also claims he failed to do his fiduciary duty. It's not clear he knows that that would actually be. (The price agreed to (\$500K) exceeds the SEVx2 (\$458K) by \$42K.)

5-29-2018	Hal sends note to Joe Weiler and Drummand Black requesting review of Joe's conduct.

Hal writes the following e-mail to the current Trustees regarding difficulties in Trust management they utilize, in this case for setting up flights for a trip being planned to Colorado that will include Anne.

I'm sorry, but I don't understand. It seems to me there is room for improvement in the current Trustee oversight process. Why can't Anne handle her own transactions with a cash advance or a reimbursement, or possibly a joint checking account, of the same type I wish we would have set up for our mom before she died....

July 2019	Hal, Alan & Anne visit Colorado to visit Uncle Bob and Jim McNamara.
Fall 2019	At some point Anne's aging Toyota Corolla was having problems (window control, etc) and I suggested she consider getting a new one. Anne had liked the Subaru Crosstrek. Chris and Cynthia strongly favor Subaru.
Xmas 2019	Hal visits Anne and the two of them look at Ford cars together. Anne likes the EcoSport. It has a higher seat height which Anne likes as she can see well and get in and out easier. She also likes the fact that the dealer is 2 miles from her, whereas Subaru is in Bay City. She and Hal begin looking at lots of Crosstreks and EcoSports that are for sale.
12-26-2019	After a test drive Anne decides she would like an EcoSport. (She also drives a Crosstrek.)
1-9-2020	It was made clear the Trustees would not approve the purchase of a new Ford EcoSport even though it was lower priced than a used Subaru they would approve unless Hal can

negotiate a price lower than A-Plan price. Hal indicates this is not possible.

Hal & Anne begin looking for used EcoSports.

1-26-2020	Hal finds a used EcoSport in Ypsilanti that meets all of Anne's criteria priced at \$18,318. Hal is told to get the price down to \$17,000 including trade in. Again, this is not possible. Cynthia also tries, but Butman Ford isn't interested in Anne's Toyota. The deal falls thru.
1-31-2020	Cynthia purchases a 2018 EcoSport from Midland Ford, who gets the car from a Ford dealer in North Dakota. A Midland Ford employee is flown out there to drive it back. The car costs over 2 grand more than the one that fell through in Ypsi including trade-in. (They gave \$1000 for her Corolla. Hal had offered to sell it. KBB was over \$1500.) So the actual delta was close to 4 grand. Hal is very frustrated, but Anne has a new car.
3-04-2020	Final settlement of Wolfe estate is finally made 3.5 years after Ellen died. (\$17,783 each)
9-11-2020	Chris makes demand that Hal pay Anne to take care of Sandy during canoe trip. (e-mail) Hal finally requests reimbursement for two trips he included Anne. (9-11-2020 e-mail) Chris states that he must first see a receipt for payment to Anne for dog-care services before he will consider any reimbursement for the trips. (e-mail)
January 2021	Hal finally gets credit card records and submits request for repayment of travel expenses for Anne, and is paid the ~\$900.
4-3-2021	Hal sent formal letter to Trustees requesting info & changes including travel companion. Hal also formally requests a financial accounting of the Trust, and points out that it is legally required. The response from Chris is that I should cease and desist from making suggestions regarding Trust management.
~May 2021	Hal gets call from insurance company indicating Mom has an open life insurance policy.  Hal sends insurance package to Olympia vis certified mail. It is returned.  Hal resends it via standard US mail. It is then received.  Anne says she has seen this before, also Cynthia will only respond if >\$1000  Amount turns out to be about to \$5000 (\$1,167 each paid on 7-20-21)
June 2021?	At some point around this time Hal got fed up not having a copy of Anne's Trust and he went directly to Chalgian & Tripp and requested one. Chrysa talks to Hal and will NOT provide him a copy for whatever reason. But she states that she will give one to Anne. Hal returned shortly with Anne and she then gave Anne a copy. This was an unnecessary And rather humiliating scenario. Hal then learns that the Trustees are required to supply ALL family members with an annual financial accounting.
July 2021	Anne invited to Olympia for Aunt Cherie's Memorial. She travels alone on 6 AM flight. On way out in SEATAC airport she falls & cuts her face and loses a tooth.
7-11-2021	1095 (dividend income) statements provided in lieu of an actual financial accounting.
9-9-21	E-mail exchange btw Anne & Cynthia – Anne asks for actual financial info, gets angry reply. (ENOUGH! Hal begins work on a law suit to remove the current Trustees.)
9-23-21	Chris turns 70 and has family party in Detroit. Lena and Adam were there. Laura and Ethan flew in from Colorado. Joel and Sue attended. Claudia was invited. Anne was not invited. (She was upset. Hal wasn't invited, nor was he expected to be.)

12-12-2021 Lawsuit filed in Midland Court (It was ready before Thanksgiving, but held back.) 1-17-2022 First financial report of Trust supplied by Cynthia for 2018-2021 (hand written) Family meeting held on Zoom. Joe Weiler orchestrated it. (Geoff Malicoat participated.) 1-25-2022 2-28-2022 First hearing held in Midland Probate Court regarding Trustee removal suit. (Postponed from Feb 1.) Two additional hearings on March 30(?) And April 26. 4-20-2022 Hal replies to Chris's email note of April 14 reply to a note of Anne's in which he describes the use of Trust funds to defend Trustees as "standard". My reply (in which I stated that there was very little about the Trust itself that was standard in my opinion.) triggered a very angry call from Joel to Anne. Very sad. 4-26-22 Anne's lawyer George issues a proposal for a "mini-Trust" funded with 10 grand / year. 5-1-2022 (approximate date) Anne fields an angry phone call from Cynthia in which (in Anne's own words) "Cynthia yelled at me and for the first time ever, I yelled back." At which time Anne said that Chris took the phone from Cynthia and he proceeded to yell at her. This is what Anne must endure at the hands of the family members that are entrusted for her care. 5-10-2022 (approximate date) After Anne writes a note to Lena asking her if she might be willing to be tapped as a successor Trustee to help manage the "mini-Trust" that her lawyer has proposed (to which Lena politely declined as Anne stated.) Anne soon fielded a very angry phone call from Cynthia in which Cynthia berated Anne for involving her daughter in these affairs. (The reason for the approximate date on these two notes is that Anne has endured so much of this crap, that she doesn't bother to let me know promptly, but generally when I visit her in person, she will let me know what has been going on.) In this case she told me that she reported this incident to her lawyer and that contact with Cynthia was now limited, which is good news for Anne, but another sad development. Hal get's call from Geoff – the Trustees have supplied him a copy of 5 years' worth of 5-13-22 financial information. Joe Weiler's office put it together for the Trustees. Not sure if any of it was contracted to Yeo & Yeo. How much this cost and why it needed any involvement form Joe has not been made clear. 5-23-22 I had a discussion with Anne. She had previously pressed me in what I might concede to drop the lawsuit. (At one point I had told her that if a mini-Trust of 15 Grand was agreed to with Alan and I as Trustees (and a succession plan for that), giving Anne a \$12,000 per year travel budget (with an inflation provision) and her discretion on a Trust paid travel companion, plus the disgusting "Cynthia clause" (remaining after Chris dies) removed from the Trust (for Susan also) I would consider dropping the suit.) She told me that she had talked to Chris and he emphatically told her he would never agree to the mini-Trust concept. So Anne's hopes for some resolution went down the toilet with that, which was no surprise to me that Chris would not accept anything except his complete and total control.

Court hearing to go over 5 years of Trust accountings. Family members were invited for

the first time. (This hearing was cancelled by the Judge for unspecified reasons.)

6-2-22

7-5-22 Anne's cancer diagnosis becomes known. Chris asks me again to drop the lawsuit. Mediation session was planned but cancelled – purportedly due to water damage to the 7-21-22 mediator's office in Bay City. Of note - Geoff offered to host it in his office. That offer was declined. 7-27-22 Hal drafts his \$15K mini-Trust proposal. 8-2-22 Trust financial review finally occurs. (4th hearing) I was online for 15 minutes but a Zoom session never opened so I signed off. Apparently it was a private meeting for most of an hour, at which time it was finally opened up. Why was that protocol used, and also kept secret? 9-9-22 Hal drafts a 3 page letter for the mediator (as requested) presenting his feelings on the Trustees and the case against them. 9-20-22 Anne endures an hour-long phone call from Cynthia. She pressures her to ask that I drop the suit. Anne misses an appointment for 2 injections during this extended conversation. Anne refuses to concede to Cynthia's demands. 9-21-22 Joe issues a bogus 1 page letter prior to the mediation session accusing Hal of selfish maleficence and also stating that Anne has no issues with the Trustees, which is a disgusting lie. 9-22-22 Mediation session in Bay City at the mediators office, where the elevator didn't work, nor did the drinking fountain. Anne and I attend in person. It ended at 1:30 PM. There were no breaks or any info provided ahead of time about protocol. It was the same day as Anne had her 11 AM chemo-therapy into session (Dave R. came along and took her back to Midland for that), and also a 2 PM wig appointment, which I took here to. Chris didn't attend – he was fishing in Alaska with Joel. So why was this date chosen? Follow up (5<sup>th</sup>) session with the Judge and the lawyers. A 2<sup>nd</sup> mediation session is 9-27-22 mandated for Thurs. October 13, possibly in Joe Weiler's office. (4<sup>th</sup> session with the lawyers only, or the 5<sup>th</sup> if you include the closed portion of Joe's financial review.) 10-4-22 Hal submits a new \$10 – 15K mini-Trust proposal. 2<sup>nd</sup> mediation session held at Joe Weiler's office. (Geoff and Anne & George were there. 10-13-22 I was on the phone.) 10-21-22 End of family negotiations set by Court. Final (6<sup>th</sup>) hearing with the lawyers and Judge Allen. 10-25-22 1-9-23 Hearing with Judge Allen regarding Hold Harmless Agreement – I was given 24 hours to sign Joe Weiler's version of the agreement. 1-20-23 I capitulate and sign the agreement Joe wrote as I am forced to due to prevent Contempt of Court charges from proceeding against me and Joe further burdening Anne's Trust. I also exercise freedom of speech rights and add a letter explaining how disgusted I am. I also formally resign as a Trustee for Anne's mini-Trust. I can no longer consider having

to report to Cynthia as this situation would require. I can't tolerate further mental abuse.

- 2-1-23 Hearing regarding Contempt of Court. I talk with Geoff he felt the hearing should be cancelled since I signed Joe's agreement. (Anne's lawyer agreed.) The hearing does take place and Joe reports I am in contempt for not showing up, although I had not been subpoenaed.
- I am served a Contempt of Court notice at home by a Washtenaw County Sherriff's deputy that states I need to report to the Midland County jail on Feb 8 unless I somehow resolve the Contempt charges against me, but there is no indication of how I am to do that. It seems that the Court did not accept my signature on the Hold Harmless agreement I signed since I had also included an additional note registering my honest feelings about the disgusting nature of being forced to sign an agreement that states within it that I am signing voluntarily, and my distain for the lawyer that created it, and the Court that required me to sign it "voluntarily". I am told I need to sign the exact same thing again (and again voluntarily, but under threat of having to go to jail if I don't agree to voluntarily sign), only this time not include anything else.
- I am so highly disgusted that I strongly considered going to jail, as I can't for the life of me see how I can be found in Contempt of Court for exercising my 1<sup>st</sup> Amendment rights. (I feel as if Judge Allen should be working in Red China.) I talked to many people including my lawyer, and eventually signed the exact same document a 2<sup>nd</sup> time and my lawyer delivered it to the Court. Hopefully I will not be required to report to prison, but possibly they will find another reason for my incarceration, such as they might infer that my signature was disingenuous, or that the writing wasn't clear enough, or any BS that my brother's lawyer (Joe Weiler) & the Judge (Dorene Allen) are so full of.
- I submit an updated copy of the Mini-Trust agreement with the wording altered from me as Trustee to Alan. I submit a red-colored-font copy of it to my lawyer and to Alan to review. I also recommend that the quarterly reporting requirement be dropped, and that the clause requiring another consent document be signed by the Trustee be eliminated.
- ~3-15-23 Two horrible e-mail notes were forwarded from Chris and Joel.
- ~4-1-23 I told Anne that there was no need to visit Midland to set up an account with Isabella Bank. Anne said she mentioned that to Cynthia who responded, we'' we've heard different things from different people."
- ~4-20-23 Anne told me that Cynthia called her (or Anne called Cynthia, not sure) and was very rude. She said that she would only talk to her about financial issues, nothing else.
- 4-23-23 Anne and I talked on the way to Charlevoix and back. Anne mentioned the phone call with Cynthia again, and indicated that she didn't see how Cynthia could be her Trustee.
- 6/1/23 A final financial review hearing held for Trust expenses for in 2022. (It was delayed from April 18 at Mr. Weiler's request.) I attended via Zoom (as did Geoff Malicoat. Mr. Weiler (and an assistant) and Mr. Phillips were there in person). I requested that Mr. Weiler supply ALL of his available expense records, certainly including December of 2022, which was omitted for reasons unclear. I also requested that Mr. Phillips supply the basics of time records, such as his hourly rate and some accounting of the hours he spent. Neither of my requests were honor by Judge Allen.
